

A. Freehold ownership : The freehold title is exclusively available to Thai buyers and

Thai companies.

B. Leasehold ownership: The leasehold title is available to both foreigners and Thai

Individuals, subject to a 30-year land lease period.

Tax and Transfer Fee Responsibility:

A. Upon the transfer of ownership, all taxes and transfer fees incurred shall be shared equally (50/50) between the developer and the buyer/lessee. Both parties shall bear an equal share of the financial obligations associated with the transfer.


